Appendix A Ohio Department of Mental Health ACT Consumer Outcomes Thresholds

I. Introduction

The purpose of this appendix is to explain the process of collecting, scoring, and submitting Consumer Outcomes data for clients receiving ACT services, as well as establishing the Outcomes Thresholds referenced in rule 5122-29-29 of the Administrative Code.

II. Definitions and Terms

The following apply to this Appendix:

- Incidents of crisis intervention mental health service. All crisis intervention activities (crisis intervention mental health, crisis stabilization unit, <u>CPST</u> crisis) related to one episode of the client's crisis shall be counted as one incident.
- Number of Inpatient Psychiatric Hospital Days: Number of days in any psychiatric bed including hospitalization in psychiatric unit of general hospital, free standing psychiatric hospital or state behavioral health organization.
- Number of Crisis Stabilization Bed Days: Number of days in crisis stabilization facility, i.e. a facility which provides crisis services to consumers that may exceed 23 hours.
- Independent Housing: includes own house/apartment, friend's home, relative's home, supervised apartment, boarding home. Independent housing does not include: supervised group living, crisis residential, nursing home, respite care, licensed adult care facility (ACF), licensed mental retardation/developmental disabilities (MR/DD) facility, MR/DD intermediate care facility, state MR/DD institution, Ohio Department of Mental Health (ODMH) licensed residential facility, general medical or psychiatric hospital, correctional facility, intermediate care facility, adult foster care home, child foster care home, and homelessness.
- Housing Quality of Life: This is a score computed by adding the scores of Consumer Form A, Questions 8, 9 and 10.
- Housing Stability: Housing stability is defined as no more than one move during the six month period. Moves include any change in housing and do not include hospitalization or incarceration. Limitations by housing programs are considered in scoring—i.e. moving out of a transitional group home because the group home length of stay is exceeded is counted as a move. This item is measured by the response to Question 4 on Provider Form A.

- Involvement with Criminal Justice System: Client avoids incarceration and has no new criminal justice involvement in the six month period. If a client is already on probation or continues involvement with a mental health court, this does not count as "new" involvement with criminal justice system. This item is measured by the response to Question 10 on Provider Form A.
- Competitive Employment means any activity conducted as part of a community job for which anyone can apply and for which the individual is paid at least minimum wage.
- Symptom Distress: This is defined as the change on the Symptom Distress score on Consumer Form A, part 3, between two consecutive six month administrations of Ohio Outcomes.
- Empowerment: This is defined as the change on the Overall Empowerment score on Consumer Form A, part 4, between two consecutive six month administrations of Ohio Outcomes.
- Quality of Life: This is defined as the change on the Quality of Life score on Consumer Form A, part 1, between two consecutive six month administrations of Ohio Outcomes.
- III. Scoring

Each item is scored 0 or 1 with the exception of employment which is scored 0 or 2. The scores are totaled. The threshold requirement is that each ACT team achieve a score of 6 points or higher for 2/3 of the persons receiving ACT services.

Notes to scoring table:

*These items must be collected by the agency for the six months prior to admission and reported to ODMH or its designee. It is assumed that the agency has outcomes measures for 6 months prior to ACT admission and will use those data. The data for these items are collected and reported within 30 days of admission. Agencies shall document any instances where this data is unavailable.

**These items require comparing data with data at previous measurement point.
