RULE SUMMARY

The Department of Mental Health and Addiction Services (Department) has historically regulated residential facilities which were operated for persons with mental disabilities. The Department has also been given the regulatory authority of two other types of facilities, adult foster homes and adult care facilities, which were previously regulated by other agencies. Changes to the statutory language regarding residential facilities occurred in H.B. 59 of the 130th General Assembly, and the manner in which facilities were categorized has been changed. Until now there have been three separate O.A.C. chapters regulating residential facilities under the Department#s authority. This rule action brings all rules regarding residential

facilities under the Department#s regulating authority up to date with current statutory authority and standardizes requirements across all facilities as much as possible. Going forward O.A.C. Chapter 5122-30 will be the chapter containing all residential facility rules. O.A.C. Chapters 5122-33 and 5122-35 are being rescinded in their entirety as part of this action.

This rule sets forth safety requirement for residential facilities and has been updated in cooperation with the Office of the Ohio State Fire Marshal. Facilities shall be held to the requirements of the board of building standards and the state fire code. Fire extinguishers and smoke detectors are required to be tested and inspected in accordance with the state fire code. Other safety items regarding portable heaters and bathrooms have been updated. It is being rescinded and filed as new as the content is over fifty percent changed.

This rule sets forth the physical safety related requirements for residential facilities. The rule consolidates safety features found across the former 5122-30, 5122-33, and 5122-35 Chapters. There are new requirements, particularly with regards to fire safety, that will present a cost to providers. For facilities formerly under 5122-33

and 5122-35 with more than nine residents, there may be a need to upgrade to integrated smoke and fire alarm systems depending on the facility's existing system. Costs for such systems are based on the square feet, and range from \$1-\$2 per square foot to \$3-\$4 per square foot for more complex systems. Monthly monitoring fees tend to fall in the \$50-\$60 range, and typically include an annual inspection of the system.
