Sleeping and living space.**RULE SUMMARY**

6. State the reason(s) for proposing (i.e., why are you filing,) this rule:

The Department of Mental Health and Addiction Services (Department) has historically regulated residential facilities which were operated for persons with mental disabilities. The Department has also been given the regulatory authority of two other types of facilities, adult foster homes and adult care facilities, which were previously regulated by other agencies. Changes to the statutory language regarding residential facilities occurred in H.B. 59 of the 130th General Assembly, and the manner in which facilities were categorized has been changed. Until now there have been three separate O.A.C. chapters regulating residential facilities under the

Department's authority. This rule action brings all rules regarding residential facilities under the Department's regulating authority up to date with current statutory authority and standardizes requirements across all facilities as much as possible. Going forward O.A.C. Chapter 5122-30 will be the chapter containing all residential facility rules. O.A.C. Chapters 5122-33 and 5122-35 are being rescinded in their entirety as part of this action

This rule sets forth the standards for sleeping and living space. Paragraph (A) sets forth the bedroom requirements for the new facility categories. Bedrooms are to have enough room for wheelchairs and walkers, and are to be shared only with other residents. Paragraphs (J) and (K) are additions from Chapters 5122-33 and 5122-35, and require adequate living and dining space for residents. It is being rescinded and filed as new as the content is over fifty percent changed.

NOTE - This rule was withdrawn from the final filing of the other rules in 5122-30 and is being filed again. There was a software problem that caused paragraph (N) to be blank, and deleting text from the rule. This was not detected by the Department or LSC until after the rule was final filed. No content has been changed, and the rule was originally reviewed by the CSI office and stakeholders during comment periods before the problem occurred. Because of the planned effective date of January 1, 2018, this filing is the simplest manner in which to correct this problem.
