This rule describes that, in a Type 1 facility, staff must always be present when

residents are present, a staffing ration of 1 staff for every 10 residents in a facility that services children, that a facility shall ensure it has qualified staff to meet the each resident's treatment plan requirements, and that a crisis stabilization unit must have the ability to adjust staff based on resident needs. The rule also states training and staff requirements when a Type 1 facility uses students or volunteers.
