The rule changes are primarily to address the requirement to develop a participation agreement. The changes add a definition of "mental health resident program participation agreement" and the existence of current valid mental health resident program participation agreement between adult care facility and local ADAMH/CMH board as a factor to be considered by the reviewing agency in determining whether the proposed placement of an individual with mental illness who is receiving RSS payments in an adult care facility would be an appropriate placement. There are other, minor updates to rule language. This rule sets forth the duties and responsibilities of mental health boards and mental health agencies to work with passport administrative agencies to recommend whether a facility is appropriate for individuals receiving residential state supplement payments and to provide ongoing monitoring and discharge planning for such persons.
