This rule is being amended to reflect changes made by renumbering by 129th G.A., H.B. 153.

The rule exempts adult family homes from building inspections by a certified inspector/department of commerce, and fire inspections by the state fire marshal or fire inspector official. The rule lists the standards with which an adult family home must comply, and that ODMH shall conduct the inspection.

The changes are made to correct ORC and OAC references based upon rule renumbering under H.B. 153 of the 129th G.A., and to change references from the Department of Health to the Department of Mental Health.
