Additionally the total loan repayment amount has been increased from \$88,000 to \$150,000, and the yearly cap has been increased to \$30,000. Throughout the rule has been amended to allow the Director's designee to take actions in this program in the Director's place.

The department across its facilities has averaged funding 5.15 loans per year over the last four years. If the number of loans in the program remains constant, the increased annual loan repayment limits could allow for an annual increase of \$31,000, or a \$62,000 increase over the biennium. This estimate is an upper limit that would be reached only if the annual limits for all loans in the program were reached. The funding for the increased payments will come from budget efficiencies in regional psychiatric hospitals and loan repayment offers will be contingent upon available funding.
