RSS administrative agency, but that area agencies on aging assist with level of care determinations and county departments of job and family services (CDJFSs) determine financial eligibility for the Program and (2) eliminate the definition of "living arrangement." This is no longer needed because a list of eligible living arrangements is in O.A.C. 5122-36-02.
