The Residential State Supplemental Program rule 5122-36-02, eligibility criteria, is being updated to implement a change recommended by the RSS stakeholder workgroup convened by H.B. 59. Per that workgroup's recommendation individuals participating in the RSS program will be able to use living arrangement housing sixteen or fewer individuals. Individuals currently in the RSS program and in living arrangements housing more than sixteen individuals may continue in their current living arrangement for as long as they remain in the RSS program.

Paragraph (A)(2) is updated to use current statutorily prescribed living arrangements and implement the RSS stakeholder workgroup recommendation of a size limitation for allowed living arrangements.
