It reorganizes and clarifies the provisions from rule 5160-4-02.1 for improved readability and ease of understanding. Like rule 5160-4-02.1, it requires the submission of documentation along with a claim for by-report procedures, services, and supplies. Unlike rule 5160-4-02.1, it does not specify exactly which documents are to be submitted; instead, because a variety of supporting

documents may be acceptable, it includes a non-exhaustive list of examples (e.g., operative reports, clinical assessments, or other medical records).

The policy embodied in the rule is being relocated to Chapter 5160-1 of the Ohio Administrative Code (General Medicaid provider policies) because it applies to a broader range of procedures, services, and supplies than are addressed in Chapter 5160-4 (Medical/surgical services).
