Rule 5160-10-09, "DMEPOS: apnea monitors," sets forth coverage and payment policies for apnea monitors used in the home. This rule replaces a rescinded rule of the same number and tagline. The rule body is extensively reorganized. Focus is shifted from the certificate of medical necessity (CMN) form to the criteria used to determine medical necessity. An unnecessarily redundant reference to a 'qualified licensed prescriber' is replaced by 'qualified prescriber'.
