This rule is being proposed for amendment to allow the Department of Developmental Disabilities (DODD) to prior authorize private duty nursing (PDN) services for individuals enrolled on a DODD administered waiver. Additional changes were made to clarify roles and responsibilities of entities responsible for authorizing PDN services, to correct rule and form citations, and to change terminology used in the rule to ensure consistency with terms used in other Medicaid chapter rules. In addition, typographical errors were corrected, such as

reflecting accurate rule citations and removing redundant punctuation.

  - 1. References to "children and adult" are being changed to "individuals" in Paragraphs (B) and (C) for continuity and to allow for the consistency with terminology used in other parts of the Department's division of rules;
  - 2. Paragraph (B)(2)(b) was added to reference the individual#s right to request a hearing should the individual disagree with the amount, scope, and/or duration of PDN services authorized by ODM;
  - 3. Paragraph (C) is being revised to remove references to the Ohio Department of Developmental Disabilities (DODD) to the newly created Paragraph (D); and
  - 4. Paragraph D is being created to capture a new provision (i.e., which will allow DODD to prior authorize private duty nursing services for individuals enrolled on a DODD administered waiver).
