Ohio Administrative Code Rule 5160-12-02(I)(2) is amended to replace "Requires" with "needs" so that the rule says "(2) Needs, as ordered...."

Ohio Administrative Code Rule 5160-12-02(I)(2) is amended to delete "...cannot be" of the rule now says "Services for habilitative care as defined in paragraph (D)(1) of this rule are inappropriate...."

Ohio Administrative Code Rule 5160-12-02(J)(2) is amended to replace "requires" with "needs" so that the rule says "...adult needs, as...."
