nursing visits. Changes to the rule include:

1. The opening paragraph is being moved to new paragraph (A) to comply with rule writing guidelines of the Ohio Legislative Service Commission, thereby effecting subsequent paragraphs (B), (C), (D) and (E) accordingly.
2. Term "face to face" is being changed to "in-person" and lapse between home health nursing and private duty nursing was clarified in paragraph A.
3. The term, "consumer", is being changed to "individual" throughout the rule.
4. The Ohio Administrative Code references are changed due to the creation of the Ohio Department of Medicaid by Am. Sub. HB 59 of the 130th General Assembly and the subsequent renumbering of rules by the Legislative Services Commission.
5. Sentences were restructured for clarity and/or other non-substantive purposes.
