Rule 5160-12-05, entitled "Reimbursement: home health services," sets forth the definitions and billing procedures for providers of home health under Ohio's Medicaid State Plan. The planned proposed amendment includes an increase to the maximum allowable reimbursement for the home health services set forth in Appendix A and Appendix B as a result of house bill 33. In addition, Am. Sub. H. B. 166 (133rd G. A.) lists six terms that cause a rule to be deemed to contain regulatory restrictions: "shall," "shall not," "must," "may not," forms of "require," and forms of "prohibit." All of these terms have been removed and the passages in which they appeared have been recast.
