All EPSDT rules are being proposed for rescission and will be replaced with a single new rule, 5160-1-14, that consolidates and streamlines the rules to be rescinded. The new rule 5160-1-14 is being relocated to Chapter 5160-1 because its

provisions apply to the entire range of Medicaid services.
