Rule 5160-2-70 sets forth the guidelines for participation in the Children's Hospitals Quality Outcomes Program (CHQP). The rule details the goals of CHQP, which requires participating hospitals to actively engage in quality efforts to reduce harm and improve quality of care, in order to qualify for payment. The participating hospitals must submit documentation to ODM to verify its participation in CHQP's initiative to reduce harm.

program as quality efforts to reduce harm vary in cost. However, participating hospitals will receive \$16.1 million in revenue, which will help offset any additional costs associated with reducing harm.
