The proposed amendments to this rule are intended to continue the reform and modernization of the outpatient hospital reimbursement methodology.

Page 2 Rule Number: **5160-2-75** 

Rule 5160-2-75 sets forth the outpatient hospital reimbursement methodology for hospitals subject to the enhanced ambulatory patient grouping system (EAPG) prospective payment methodology. The formula used to calculate outpatient payments will not change.

Paragraph (A)(4) will be updated to remove "and" and add "or both".

Paragraph (G)(1)(a)(i) will be updated to add "billed with revenue center code 25X or 623".

Paragraph (G)(1)(a)(iv) will be added to include payment logic for pharmaceuticals listed as "by report" or unlisted on the Provider Administer Pharmaceutical fee schedule, which can be found on the Ohio Department of Medicaid website at http://www.medicaid.ohio.gov/.

Paragraph (G)(1)(f)(iv) of this rule will be removed to eliminate the discounting factors applicable to observation services.

Paragraph (H) of this rule will be added to include payment for acupuncture services limited to the treatment of low back pain and migraine headaches.
