OAC rule 5160-20-01 sets forth provisions for the coordinated services program

(CSP). CSP requires a Medicaid beneficiary to obtain healthcare services from a designated provider. Changes to the rule include: adding a definition of "individual," updating the time periods for enrollment from 18 months to 24 months and clarifying the acceptable types of designated providers. Other changes to the rule include updating the department's name, rule references, terminology and general edits for clarity.
