Ohio Administrative Code (OAC) rule 5160-20-01 sets forth the definitions, enrollment and exclusion criteria, enrollment and disenrollment processes, provider assignment, and individual hearing rights for the Coordinated Services Program (CSP). Changes to this rule include: In paragraph (A)(8), updated Ohio Administrative Code (OAC)

citations to include Ohio resilience through integrated systems and excellence (OhioRise); In paragraphs (D)(4) (D)(5) (D)(6), added additional enrollment criteria; In paragraph (D)(7), added additional exclusions for enrollment in the CSP; In paragraphs (F)(2) (c) and (d) added additional provisions for to include that ODM or its designee could make immediate changes to an individual's assigned pharmacy; ODM form references have been updated to reflect a 10/2022 effective date; In the appendix, clarified that if an individual has a history of addiction or drug dependence with abuse potential drugs that the individual was diagnosed or treated for addiction and the individual received any combination of any OARRS reportable drugs or any muscle relaxants and in the appendix, amended language to include if an individual utilizes three or more pharmacies to fill abuse potential drugs (previously it was four or more pharmacies).
