This rule sets forth the definition of an ambulatory surgery center (ASC), how an ASC can become an eligible Medicaid provider, covered and non-covered surgical procedures allowed in an ASC, covered ASC facility services, and payment policies for facility services, laboratory services, radiological services, and diagnostic and therapeutic procedures.
