This rule sets forth the eligibility criteria for individuals who are then enrolled in

the managed care program and the enrollment process. Changes to the rule include: in Paragraph (C)(1)(e), the 'and' has been replaced with 'or' to clarify when the MCP is responsible for member coverage; Gender identity has been added in paragraph (C)(1)(a) in compliance with 42 C.F.R. 438.3(d); Ohio Administrative Code, United States Code (U.S.C) and Code of Federal Regulations (C.F.R) references were updated. General edits were made to terminology, grammar and formatting.
