This rule replaces rule 5160-3-06 of the OAC which has been rescinded in compliance with 5 year review and to implement policy change.

This rule sets forth the criteria for determining a protective level of care. Changes

to the rule include: State agency name references, form numbers, and rule number references were updated to reflect statutory and Administrative Code changes; Clarified that protective level of care is specific to the adult population with the exception of individuals# age 18 through 20 years who are residential state supplement applicants; Removed unnecessary references to the Intermediate, Skilled and ICF-MR levels of care; Detailed the components of activities of daily living (ADLs); Updated the components of instrumental activities of daily living (IADLs); Added the use of an ODM approved assessment instrument to determine the need for less than twenty-four hour support in order to prevent harm due to a cognitive impairment, when diagnosed by a physician.
