Page 2 Rule Number: 5160-3-08

This rule sets forth the criteria for nursing facility-based level of care for an adult. Changes to the rule include: State agency name references, form numbers, and rule number references were updated to reflect statutory and Administrative Code changes; Clarified that this rule is specific to the adult population; Updated the Department of Developmental Disabilities (DODD) rule references and related terms; Added an adult who has a diagnosis of a developmental disability, but not an intellectual disability, and who is likely to require lifelong assistance with activities of daily living (ADLs) due to a physical impairment may meet the intermediate level of care; Detailed the components of ADLs; and Added the use of an ODM approved assessment instrument to determine the need for twenty-four hour support in order to prevent harm due to a cognitive impairment, when diagnosed by a physician.
