This rule replaces rescinded rule 5160-3-08, which was rescinded because more than fifty per cent was changed during the review process.

This rule sets forth the criteria for nursing facility-based level of care for an adult. Changes to the rule include: state agency name references, form numbers, and rule number references were updated to reflect statutory and Administrative Code changes; clarified that this rule is specific to the adult population; updated the Department of Developmental Disabilities (DODD) rule references and related terms; detailed the

components of Activities of Daily Living (ADLs); added the use of an ODM approved assessment instrument to determine the need for twenty-four hour support in order to prevent harm due to a cognitive impairment; added language that will allow an adult who initially met skilled level of care and was enrolled on a Medicaid waiver to remain enrolled when certain criteria are met.
