This rule sets forth the Resident Review requirements for individuals residing in nursing facilities. Changes to the rule include: Changed state agency name references, rule number references, and form name/number references; replaced the term "mental retardation" with the term "developmental disability" added the use of an ODM approved system for use by nursing facilities to submit the resident review to the appropriate agency, removed redundancies.

There are no new costs associated with the changes to this rule. It is expected that the changes allowing for nursing facilities to utilize the electronic system as approved by ODM will result in a cost savings to the nursing facilities submitting resident review forms.

Nursing facilities are required by federal law to comply with resident review (RR) by completing the necessary forms and submitting to the appropriate agency for review. Costs will vary depending upon the nursing facility and how they submit thier resident review forms. It is estimated that nursing facilities will see a cost savings due to the rule changes allowing for submission of RR forms via an electronic system approved by ODM.
