The Department estimates it costs approximately \$379.80 for a nursing facility provider to prepare and file an annual Medicaid cost report. This figure is based on an estimated 15 hours of staff time at \$25.32 per hour, which is the statewide median hourly wage for an accountant in Ohio.

However, there are no new costs of compliance.
