- 2) To move the definition of "CDJFS" to paragraph (E);
- 3) To move the definition of "C.F.R." in paragraph (F);
- 4) To replace the term "consumer" or "consumer's" with "individual" or "individual's" in paragraphs (G), (H), (L), and (Y);
- 5) To revise paragraph (L) to reflect that ODM holds the State's contract with the FMS and to clarify that this entity is to be used with the participant direction authorities available in PASSPORT;
- 6) To revised paragraph (O) to reflect that an individual includes an individual who is enrolled in Medicaid and also enrolled in a HCBS program, or an individual who is applying for HCBS or other long-term care;
- 7)To add paragraph (P) which includes a definition for the term "individual provider", which reflects the addition of new services and participant-directed providers to the PASSPORT waiver;
- 8) To amend paragraph (Q) to clarify the definition of a Keys Amendment Facility for the purposes of the waiver program; and
- 9) To amend paragraph (U) to delete the definition of ODJFS and insert the definition of ODM.
