This rule sets forth the services that are available under the PASSPORT waiver program.

Changes to this rule include:

- 1) Adding new services in paragraphs (B)(2), (B)(3) and (B)(16), and revising the list of services in paragraphs (B)(1) through (B)(18) in alphabetical order;
- 2) Revising paragraph (C) to replace the term consumer with the term individual;
- 3) Revising paragraph (D) to replace the term consumer with the term individual, update the Ohio Administrative Code reference, and to clarify that the choice to use either the PASSPORT or Home Choice community transition service is at discretion of the individual;
- 4) Amending paragraph (E)to replace the term consumer with the term individual;
- 5) To add new paragraph (F) to specify the services subject to the participant direction authority added to the PASSPORT waiver and identifying which authority identified each service is subject to;
- 6) Update paragraph (G), (G)(1), (G)(2), and (G)(3) to replace the term consumer with the term individual and to clarify that individuals who elect to direct their services must be assessed to determine their ability to fulfill the responsibilities required by managing their service delivery in accordance with rule 173-42-06 of the Administrative Code, and to link participant direction to the services in paragraph (F) of this rule.
- 7) Revised paragraph (H) to replace the term consumer with the term individual, and to update the cross reference to reflect renumbering of paragraphs in the rule.

ODM estimates that the proposed program changes will increase expenditures by approximately \$788,400 in SFY 14 and \$2,365,200.00 in SFY 15.
