The addition of new services to PASSPORT will likely increase the utilization of waiver services. Ohio Department of Medicaid, in conjunction with the Ohio Department of Aging projects that, for the biennium this increase in utilization will result in an increase in expenditures of approximately \$\$2,269,922(\$839,417 state share).
