This rule sets forth the eligibility requirements for enrollment in the Assisted Living waiver.

Changes to this rule include:

1. Administrative Code citations are updated.

3. Paragraph (B)(3) language has been clarified to reflect that the individual must reside in an approved living unit in a licensed residential care facility certified by ODA.
4. Paragraph (B)(4) has been updated to reflect the individual must have been determined eligible for Medicaid.
5. Paragraph (E) regarding eligibility for enrollment in hospice has been removed as the relationship between home and community-based service waivers and hospice coverage is addressed in rule 5160-56-02 of the Administrative Code.
