This rule is being proposed for amendment as a result of five-year review.

This rule sets forth the program administration requirements for the Program of All-inclusive Care for the Elderly (PACE), including but not limited to designation of the Ohio Department of Aging as the state administering agency. Changes include updated Ohio Administrative Code cites, Ohio Department of Medicaid references, Code of Federal Regulations effective dates and updated reference to "individual" instead of "consumer." Additionally, paragraph (B)(3) has been modified to state that the Ohio Department of Aging shall "verify that PACE organizations providing PACE services have signed Medicaid provider agreements as required by rule 5160-1-17 of the Administrative Code."
