Rule 5160-36-03, entitled "Program of all-inclusive care for the elderly (PACE) eligibility," sets forth the eligibility requirements for individuals served under the PACE program. Per the LSC guidelines, the rule is being filed as rescind/new as more than fifty percent of the rule is being amended with the addition and rescission of text. The proposed amendment reverts disenrollment requirements to what they were before the COVID-19 public health emergency. The proposed amendment also includes restructuring of sentences. In addition, Am. Sub. H. B. 166 (133rd G. A.) lists six terms that cause a rule to be deemed to contain regulatory restrictions: "shall," "shall not," "must," "may not," forms of "require," and forms of "prohibit." All of these terms have been removed and the passages in which they appeared have been recast.
