This rule is being revised to clarify the existing policy for reimbursement of assistant-at-surgery services. For assistant-at-surgery services provided by a CNS, CNM, or CNP, regardless of setting, Medicaid will pay no more than twenty-five percent of the Medicaid maximum for the covered primary surgical procedure.
