This rule sets forth coverage and payment policies for specific types of evaluation and management services (office visits).

Section 1262 of the Consolidated Appropriations Act of 2023 removes the federal requirement for practitioners to submit a Notice of Intent (have a "DATA 2000 waiver") to prescribe medications, such as buprenorphine, for the treatment of opioid use disorder (OUD). Consequently, two changes are being made to rule 5160-4-06:

- Paragraph (B)(7)(a) is struck.
- A reference to the Code of Federal Regulations in paragraph (B)(7) is updated.
