The text of the new rule is reorganized, streamlined, and clarified. Unnecessary definitions, explanations, and claim-submission instructions are removed. The word 'physician' is replaced by other terms such as 'practitioner' or 'consultant' in recognition of the expanded scope of non-physician medical professionals.
