This rule is being filed to remove two services from and to include new services to the Self-Empowered Life Funding waiver.

The purpose of this rule is to establish the SELF waiver as a component of the Medicaid home and community-based services program pursuant to sections 5166.02 and 5166.20 of the Revised Code. The following changes were made to the proposed rule:

Paragraph (F) was amended to delete community inclusion-personal assistance and community inclusion-transportation as available services and to add participant-directed homemaker/personal care, transportation and waiver nursing delegation as new services under the waiver.

The Ohio Department of Developmental Disabilities estimates that the filing of this rule package will cost an estimated \$7.6 million to add the new waiver services. The change to this rule will not have an impact on the budget of the Ohio Department of Medicaid. A waiver amendment was submitted to the Centers for Medicare and Medicaid (CMS) to add Participant-directed Homemaker/personal care and Transportation to the SELF waiver as replacement services for Community inclusion-personal assistance and Community-inclusion transportation. In addition, Waiver Nursing Delegation will be added as new service available under the SELF waiver. The proposed effective date of the waiver amendment is January 1, 2018.

The estimated cost of compliance will vary for the County Boards of Developmental Disabilities (CBsDD). Each CBDD is responsible for the non-federal share of the costs of providing services to individuals with developmental disabilities within their county.
