To update change in ODM policy related to the administration of the Home and Community Based Medicaid program. In addition, reformatting of rule content for administration of the program.

Rule 5160-41-17, (rescind) entitled Medicaid home and community-based services program-self-empowered life funding waiver. The rule was reviewed to remove an Appendix K flexibility that ended with the Covid-19 Public Health Emergency. The rule was also reformatted to align language and update references. The rule is being proposed for rescission as the reformatting altered more than fifty percent of the document. It will be replaced with a rule of the same name and number. The rule

authorizes the Department of Developmental Disabilities to oversee the day-to-day operations of the Home and Community Based Services Self-Empowerment Life Funding (SELF) waiver program for individuals with a developmental disability level of care. The Appendix K flexibility of allowing state agency provider certifications to be accepted among different agencies has been removed. Rule language also outlines purpose, definitions, request for a referral, eligibility, enrollment, continued enrollment, limits on services, service plan requirements, provision of services, provider payment standards and monitoring, compliance, and sanctions.
