- Removes paragraph (B)(1), permitting use of waiver nursing in lieu of similar services when they are available;
- Permits face-to-face visits required by this rule to be conducted by telephone or electronically, unless the individual's needs require a face-to-face visit.
- Permits the Ohio Department of Medicaid and the Ohio Department of Aging to deem any ODM, ODA or Ohio Department of Developmental Disabilities waiver provider as having satisfied ODM or ODA requirements for same or similar services.
