This rule is being proposed for amendment for the purpose of increasing the reimbursement rates for waiver nursing and personal care aide services provided under the Ohio Home Care Waiver, codifying overtime rates and billing procedures for non-agency providers of waiver nursing and personal care aide services, and

This rule sets forth the reimbursement rates and billing procedures for the Ohio Home Care Waiver. It is being amended for the purpose of increasing reimbursement rates for waiver nursing and personal care aide services provided by agency and non-agency providers and codifying overtime rates and billing procedures for waiver nursing and personal care aide services provided by non-agency providers. The rule is also being amended to modify the definition of "group setting" as it relates to the provision of waiver nursing services pursuant to Substitute House Bill 483 of the 131st General Assembly.

Pursuant to the Executive Budget, the Ohio Department of Medicaid (ODM) undertook a redesign of the rate-setting methodology for aide and nursing services available through the Medicaid State Plan and home and community-based service (HCBS) waivers, including waiver nursing and personal care aide services provided under the Ohio Home Care Waiver. The redesign took into account labor market data, education and licensure status of providers, whether providers are independent or home health agencies, and the length of time of service visits. The new rate setting methodology and rates were implemented in July 2015 (SFY 16). Separately, the SFY 16-17 budget also included a five percent increase for home health aides that took effect on January 1, 2016.

With this proposed amendment, ODM is adjusting the methodology and proposing a rate increase for the second half of SFY 17 for personal care aide services

available under the Ohio Home Care Waiver, and nursing services available through the Medicaid State Plan and HCBS waivers, again including waiver nursing under the Ohio Home Care Waiver. It is estimated this proposed rate increase will increase expenditures for the agency during the current biennium as follows:

Waiver Personal Care Aide: \$ 1,569,835 (all funds)

State Plan and Waiver Nursing: \$8,952,466 (all funds)
