This rule sets forth the definitions related to the HOME Choice program. Changes to the rule include: removed paragraph (A) as it was duplicative to the title and unnecessary; removed paragraph (B)(2)(vi) as DODD no longer administers an adult foster care service; in paragraph (C), corrected the credentials of a case manager; in paragraph (4), removed the definition of "demonstration period"; in paragraph (E), updated the definition of "guardian"; in paragraph (G), removed language related to the "demonstration period"; in paragraph (15), removed the definition of "money follows the person (MFP)"; in paragraph (19), removed the definition of "qualified services"; in paragraph (Q), updated the definition of "residential treatment facility"; in paragraph (R), updated the definition of service and support administrator; corrected the ODM form revision dates and OAC rule references; and made other grammatical and formatting edits throughout.
