The Helping Ohioans Move, Expanding Choice (HOME Choice) program is a demonstration program in Ohio that helps eligible individuals move from an institutional setting, back into the community. There are numerous activities/services provided to individuals to help with transition from an institution into the community.

This rule sets forth reimbursement rates and billing procedures for providers who submit claims for those services. It also provides definitions related to HOME Choice billing. Changes to this rule include: State agency name references, form numbers, and rule number references were updated to reflect agency name and statutory and Administrative Code numbering changes; removed unnecessary references to home and community based services waivers where applicable; clarified definitions and removed definitions not applicable to the HOME Choice program; removed redundancies; added language regarding recoupment of funds for overpayment to a provider; and extended the length of time a provider is allowed to submit a claim for reimbursement for community transition services from 15 days to 30 days. No changes are being made to the billing rate amounts.
