1. The term "consumer" is being changed to "individual" throughout the rule.

- 2. The terms "advanced practice nurse" and "certified nurse specialist" are being changed to "advanced practice registered nurse" and "clinical nurse specialist" to be consistent with the terminology used in Chapter 4723. of the Revised Code.
- 3. In the second opening paragraph, a paragraph reference is being corrected from (GG) to (HH).
- 4. Ohio Administrative Code references are being updated due to the creation of the Ohio Department of Medicaid by Am. Sub. HB 59 of the 130th General Assembly and the subsequent renumbering of rules by the Legislative Services Commission.
- 5. The Department's name is being updated from the Ohio Department of Job and Family Services (ODJFS) to the Ohio Department of Medicaid (ODM).
- 6. The name of the Ohio Department of Developmental Disabilities (DODD) is being updated from the Ohio Department of Mental Retardation and Developmental Disabilities (ODMRDD).
