This rule defines contributing service credit and full-time credit.Changes include: Simplify the definition of "full-time contributing service credit" by removing an obsolete hours base/hours paid chart;  
Remove old language that no longer applies, including a paragraph regarding members paid by annual salary, basis with no hourly compensation available;

Add a definition for the term "furlough"; and  
Permit members who may be furloughed to continue to receive full-time service credit for a maximum of 6 months if the furlough occurs between March 9, 2020 (the effective date of the emergency declared by the Governor for COVID-19) June 30, 2021 (end of the fiscal year).
