This Rule defines the term "honorably discharged" for purposes of O.R.C. Section 742.52, which requires a member to have been honorably discharged in order to purchase service credit for military time. It does not, however, reference O.R.C. Section 742.521, which also requires a member to have been honorably discharged in order to be granted service credit for military time. Thus, we are amending this Rule to include references to O.R.C. Section 742.521.

This Rule should reference O.R.C Section 742.521, which also requires a member to have been honorably discharged in order to be granted service credit for military time. The omission of this reference to O.R.C. Section 742.521 appears to be due to the fact that O.R.C. Section 742.52 was enacted in 1974, and this rule was adopted in 1981. When O.R.C. Section 742.521 was enacted in 1996, this Rule was not subsequently amended to include a reference to this statute. In light of this oversight, we are amending this Rule to include references to O.R.C. Section 742.521. This Rule defines "honorably discharged" for a member's service in the armed forces of the united states referencing O.R.C. Section 742.52.
