This Rule is being filed as part of the 5-Year review requirement.

This Rule provides for OP&F's administration of the pre-retirement survivor

annuity (PRSA) that may be paid to a member's surviving spouse or contingent designated beneficiary if the member is eligible to retire but has not yet done so. Paragraph (D) of this Rule provides that the PRSA is a 50% Joint and Survivor Annuity. However, O.R.C. Sections 742.3714 and 742.446(B)(5) already provide that the PRSA will generally be a 50% JSA. These statutory provisions go further and add an exception if a member dies while participating in DROP (the member's surviving spouse or contingent dependent beneficiary receives the greater of a 50% JSA (PRSA) or the annuity plan selected by the member made upon entry into DROP). Therefore, we are removing Paragraph (D) from this Rule.
