OAC 901-19-07 requires that all exhibition sponsors require exhibitors to attend or complete a quality assurance program or pass an exam which indicates that the exhibitor has the requisite knowledge presented in the quality assurance program.

The quality assurance program is a comprehensive educational program which focuses on the proper care and welfare of food animals. The majority of animals entered into livestock exhibitions are eventually sold and placed in food supply. Due to this eventual entry into the stream of commerce, the knowledge of food safety, nutrition, management, handling, and the environment are critical to the success of producing a safe and wholesome product. Therefore, it is essential that all exhibitors be required to participate in the quality assurance program.

The rule has been proposed to be amended to update the Appendix A to this rule. The Appendix is titled Food Animal Youth Quality Assurance Minimum Standards. The Appendix has been amended to clarify the Age & Participation portion of the document; clarifying that individuals that are 19 years of age on December 31st of the current year are eligible to participate in the junior fair shows. Further, the description of the program has been amended to give a stronger scope to the requirements of the Quality Assurance program.
