This rule will not effect revenues. The department will have an increase in expenditures as herd facilities are initially inspected, but existing personnel will be used and the cost is expected to be minimal.

The primary costs to herd owners will come from fencing requirements and the annual inspections. Existing herd owners will already have fencing in place, only new herds and expanded facilities will be impacted by the rule. Costs will vary with the size of the fence, the terrain, and the materials be used. The maximum amount of discretion is being left to the herd owner.

Annual inspections will be required of all captive whitetail deer herds. The costs will vary depending on herd size and the veterinarian conducting the inspection. Generally this will be a veterinarian visit of less than \$100. Existing herd owners in the chronic wasting disease program already have annual inspections.

Fencing must be inspected on the initial licensing or registration of a herd.

If any inspection discovers signs of chronic wasting disease, the herd may be declared ineligible for the status designations or removed from the chronic wasting disease program.

The rule requires fencing and annual inspections.
