Rule 901:1-17-09 sets forth requirements for the importation and shipment of swine into the state of Ohio. The amendment requires that the status or presence of Porcine Reproductive and Respiratory Syndrome (PRRS), if known, in any swine which is shipped or imported into the state of Ohio must be annotated on the certificate of veterinary inspection (CVI).

Rule 901:1-17-09 requires pork producers and veterinarians to annotate the presence or non-presence of PRRS on the CVI, if known. This adversely affects the community by requiring additional time for compliance. The additional time required for annotating the presence of PRRS is minimal and should have no real substantial effect on producers or veterinarians. The amendment does not require additional testing.

Importing animals in violation to this rule will subject them to immediate quarantine and possible extermination.
