Rule is being amended to simplify chronic wasting disease and pseudorabies rules.

Rule bans the importation of deer unless they have been under CWD monitoring for five years and removes pseduorabies monitoring in favor of species specific rules.

At the public hearing for this rule it was brought to the department's attention that the rule would ban the importation of non-domestic swine except for transport directly to hunting preserves. This would negatively impact a small but vital non-domestic swine breeding industry in Ohio by preventing them from resupplying their breeding stock. These breeders supply swine exclusively to hunting preserves.

In response, the rule has been changed to drop any language banning the importation of non-domestic swine. The swine will be subject to the same disease testing, permits, and certificate of veterinary inspection requirements that apply to all other imported animals. This revision will protect the health and safety of Ohio's swine population and allow the Ohio breeding industry to continue to supply hunting preserves.

At the public hearing a comment was also made in reference to the cost of the requirement that all cervidae entering Ohio have a five year chronic wasting disease monitoring status in whatever state they are being imported from. However, this is

not a new requirement in the rule and a five year status had been required since 2007. Removed from the rule was the option that a closed herd could provide documentation of chronic wasting disease status from outside of a monitoring program. This option has never been used and is being removed in order to both simplify the rule and insure cervidae health.
